Foundation, and extend the opportunity for Mr. Emmanuel Gomez to enjoy facilitated parental custody visits that require court-mandated supervision, from within our Summer Recreation in the Parks program. Summer Re provides an excellent opportunity to meet and combine both our community objectives, while also giving these children a highly positive visitation experience with their parent. We've outlined below, what we believe is an excellent opportunity to help these families thrive in our community.

Program Details:

Dates: July 7th through August 14th. (6 weeks)
Operating Hours: Monday-Thursday, 10:00 a.m. – 2:00 p.m.
Location(s): Mayhews Landing ([36380 Cherry Street](#), Newark, CA 94560) and;
Civic Center Park ([6300 Civic Terrace Avenue](#) Newark, CA 94560).
Ages Served: 5-12 years of age
Capacity: 125 children at each park, daily.
Features: Free lunch & breakfast snack daily. (provided by Newark Unified and the Federal Free Summer Lunch program)
Cost: 1-Time \$10 per child registration fee (covers the entire 6 week program)

Important Pilot Program Features & Info:

All employees are over the age of 18, and all volunteers over 16. All have background checks/LifeScan completed before being allowed to work with the children. We train them to work with the children and handle minor security and safety matters. Likewise, the local Police Department is aware of our park presence; they are immediately available for any issues that arise (one location is AT the NPD Civic Center park, the other just a few blocks away.)

Program Director: Sharon Slayton, LOV Staff
Employees/Staff: At each park - 1 Park Leader and 2 Assistant Leaders, seasonal part-time employees.
Volunteers: Additionally, there is a 1:10 ratio of Volunteers-to-children at each park.
